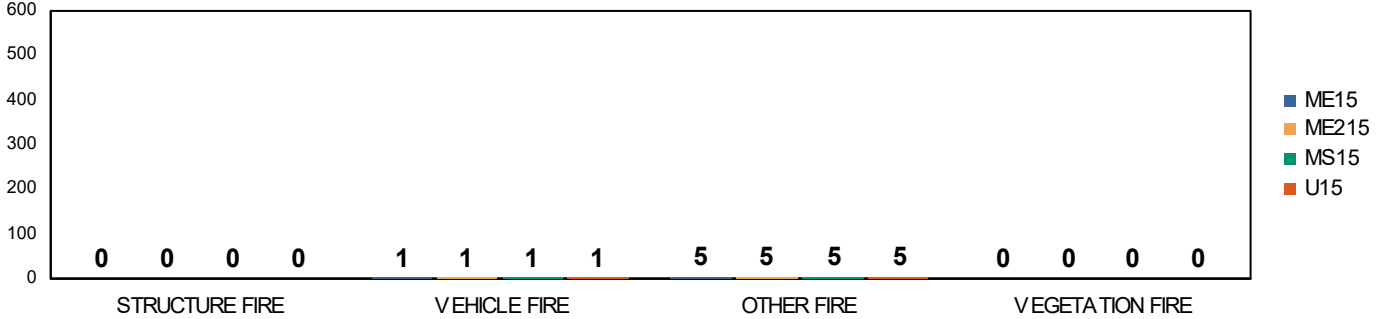

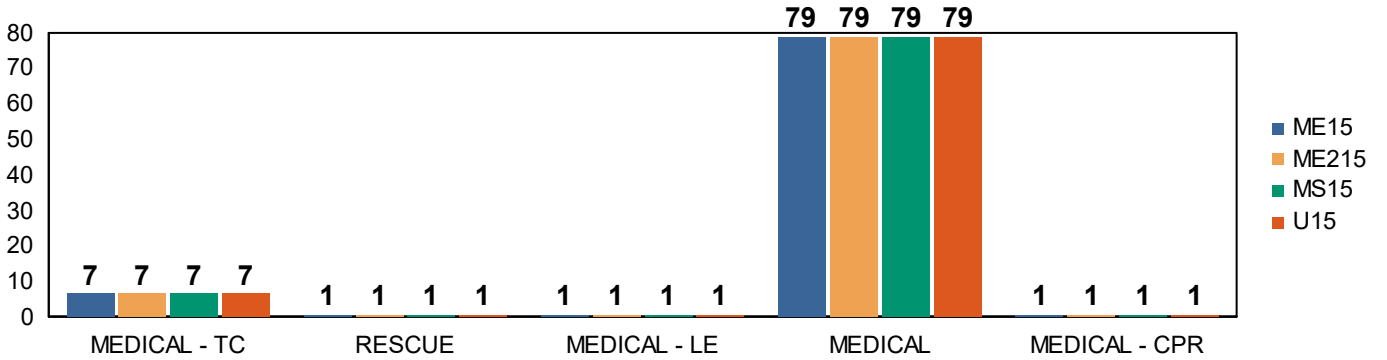


Station 15 Monthly Incident Summary

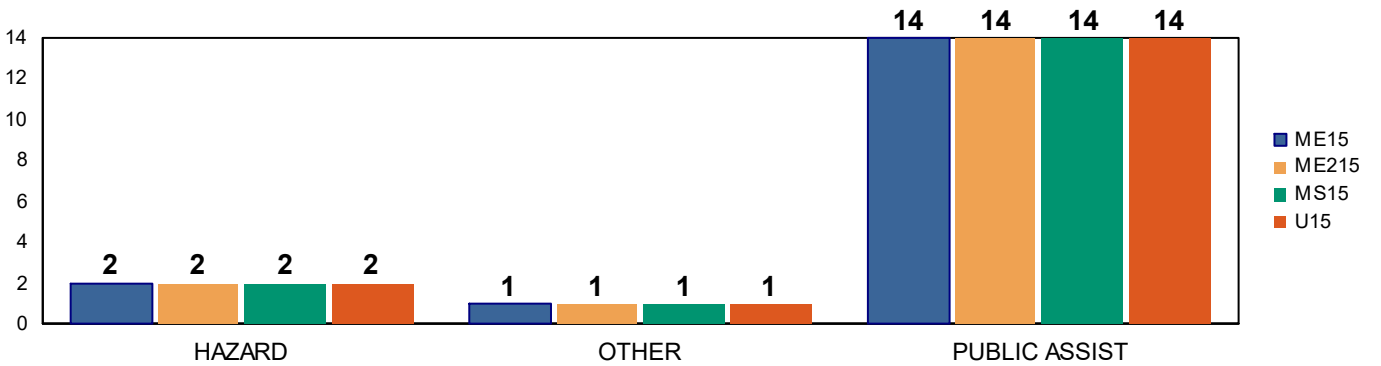
FIRES BY TYPE



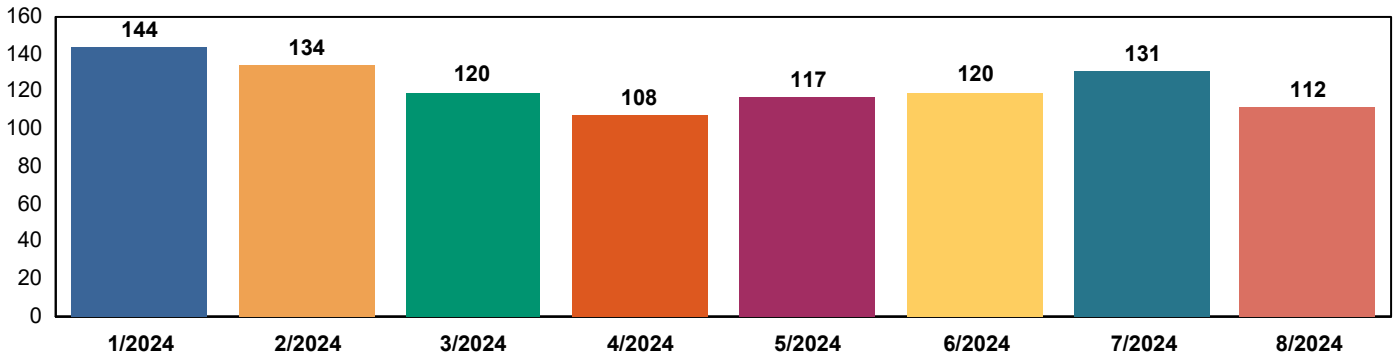
MEDICAL BY TYPE



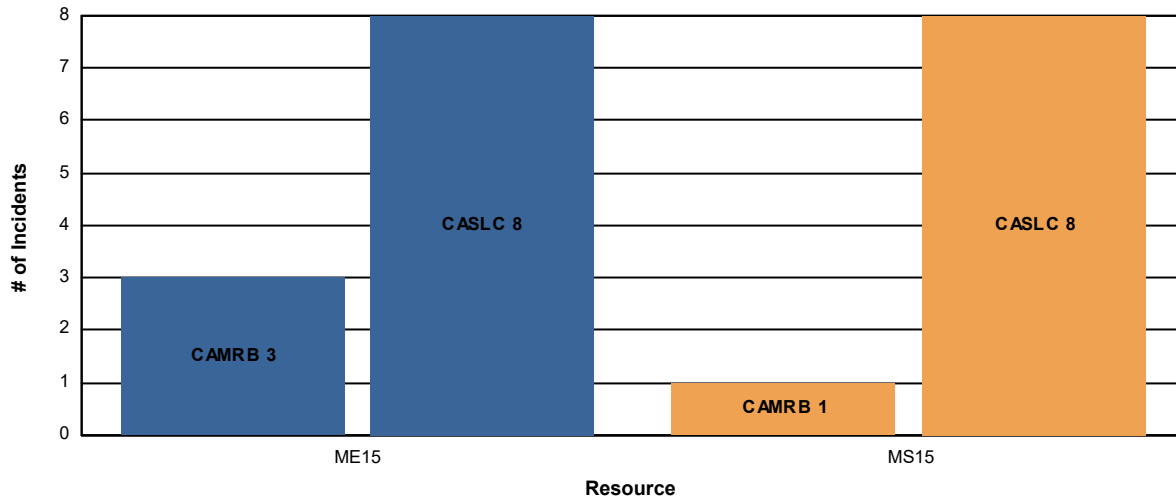
MISC CALLS



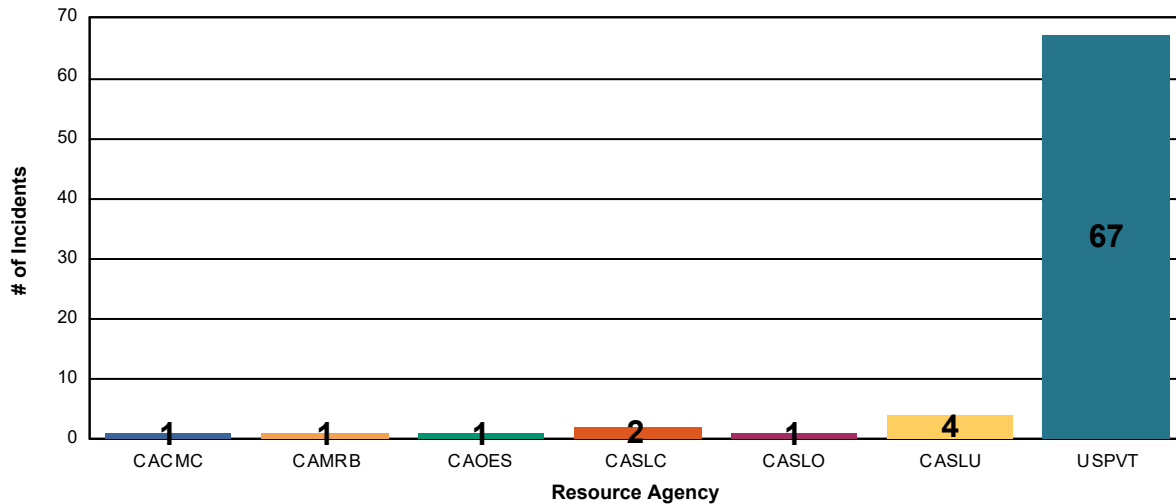
Station 15 Incidents per Month
