June General Manager's Report

SLO County Growth Management Ordinance (GMO) Update

BMC staff met with County Planning to discuss the GMO on Friday, July 26th. County staff provided a general timeline for the public outreach meetings and the date for the Board Supervisors (BOS) meetings. Schedule is as follows:

- BMC presentation- August 21st
- LOCAC presentation- TBD
- Town Hall- about 2 weeks prior to the BOS meeting
- BOS meeting- October 29th

The County is still working on the format of the Town Hall meeting but said it will cover the Los Osos Community Plan, GMO, sewer connections and Habitat Conservation Plan. They did say the format will provide ample time for community questions and answers. Additionally, this will be on the Utilities Advisory Committee meeting agenda on August 21st with any follow-up details provided to the Board at the September 5th Board meeting.

At the meeting, BMC staff was given opportunity to provide comments on the framework of the GMO; details will be available soon on the final framework of the GMO based on the discussions.

Upcoming November Board Election

There are two Board of Directors seats up for election in the upcoming November elections and the candidate filing period is rapidly approaching. The two Districts that have an available seat are Districts 3 and 5 (see the attached map for the District boundaries for these two seats). The Candidate Filing Period runs **July 15 - August 9** (extended to August 14 if an incumbent does not file).
